

**INTERFAITH COMMUNITIES IN ACTION
RELEASE OF LIABILITY**

RELEASE AND WAIVER OF LIABILITY This Release and Waiver of Liability (the "Release") is executed on this ___ day of _____ 20___, by _____ (the Participant) in the Interfaith Communities In Action's Walk to End Family Homelessness.

The Participant understands that the Walk to End Family Homelessness will consist of a walk and silly dances and that the walk will last for 1 hour. The Participant further understands that they may leave the walk at any time before the hour is over.

The Participant does hereby voluntarily, freely, and without duress, executes this Release under the following terms:

1. RELEASE AND WAIVER. The Participant does hereby release and forever discharge and hold harmless Habitat and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or equity, which arise or may hereafter arise from Participant's activities during the Interfaith Communities In Action's Walk to End Family Homelessness. The Participant understands that this Release discharges the Interfaith Communities In Action (ICIA) from any liability or claim that the Participant may have against ICIA with respect to any bodily injury, illness, death, or property damage that may result from Participant's activities with ICIA whether caused by the negligence of ICIA or its officers, directors, or agents or otherwise. Participant also understands that ICIA does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

2. MEDICAL TREATMENT. The Participant does hereby release and forever discharge ICIA from any claim whatsoever that arises or may hereafter arise on account of any first aid, treatment or service rendered in connection with the Participant's Activities with ICIA.

3. INSURANCE. The Participant understands that ICIA does not carry or maintain health, medical, or disability insurance coverage for any Participant. *Each Participant is expected and encouraged to obtain his or her own medical or health insurance coverage.*

4. PHOTOGRAPHIC RELEASE. The Participant does hereby grant and convey unto ICIA all right, title and interest in any and all photographic images and video or audio recordings made by ICIA during the Participant's activities with ICIA's Walk to End Family Homelessness, including, but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.

5. OTHER. The Participant expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Hawaii, and that this Release shall be

governed by and interpreted in accordance with the laws of the State of Hawaii. The Participant agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of the Release which shall continue to be enforceable.
